Helpful Information to Share with Survivors of Sexual Assault

- Survivors can speak with someone at any time. Reporting is always a choice. Choosing one route does not exclude other options. Survivors should pursue whatever routes will be most helpful to recovery, and that pathway may change over time.
- Confidential support is available through UAS Counseling Services (for local and distance students), community mental health care providers, religious leaders and the local women/family shelters.
- If a survivor wishes to file a criminal complaint, she/he should contact their local police department. Advocates (available through local shelters) and attorneys can accompany survivors.

UAS Employee Responsibilities

All UAS employees, except licensed confidential counselors, are required to report instances of sexual misconduct to their campus Title IX investigator (Gail Klein 4508, Chris Washko 7703, Maria Moya 6148) and/or the regional Title IX coordinator (Kirk McAllister 6473).

If the student or employee wishes to report anonymously, please contact the Title IX coordinator (Kirk McAllister 6473). This is to ensure that all campus resources are made available to the complainant and health and safety concerns for the campus community are considered. If not reported to a confidential resource, strict anonymity cannot be guaranteed but information will only be shared with appropriate university officials.

The immediate goal for the UAS Title IX Response Team is to stop inappropriate behavior, prevent its reoccurrence and provide appropriate remedies to the victim. The overall goal is to provide a safe and nurturing educational and workplace environment for our students and employees.
