#### REC CENTER AGREEMENT TO PARTICIPATE (Intramurals & Recreational Sports Participants)

However, nothing herein shall be construed so as to relieve the University of liability for claims arising as a result of its gross negligence or willful misconduct.

1.2 I hereby agree to submit any disputes that may arise between myself and the University of Alaska Southeast, its agent and employees, in connection with my recreational activities at UAS, to binding arbitration in accordance with the rules of the American Arbitration Association.
