**IMPORTANT:** United States immigration regulations require that certification of admission be based upon both academic acceptance and satisfactory evidence of adequate funds to meet all expenses that will be incurred during the student's proposed course of study. Please complete **ALL ITEMS** on this form, in English, type or print neatly in ink. All signatures must be signed in ink and NOT typed. **INCOMPLETE FORMS WILL BE RETURNED UNPROCESSED.** Undergraduate and Graduate applicants must submit this form.

Please send documents to support your financial declaration. Supporting documentation is needed for each person or party who will be contributing to the cost of your education. The documents should reflect the person's financial status over time. Examples of supporting documentation include: several months' bank statements; a letter from an employer stating period of employment, planned continued employment and a yearly salary; or a U.S. Immigration Form I-134 Affidavit of Support (for students who have a financial sponsor in the United States). All documents must be officially translated into English and the monetary amounts expressed in U.S dollars. Student need to keep a duplicate set of all documentation, the duplicate set will be necessary to apply for a visa and to enter the United States.

The costs listed above are approximate costs for one academic year based on 12 credits/semester for undergraduate students and 9 credits/semester for graduate students. Add approximately \$4,500 for summer living expenses. Transportation costs are not included. If you are bringing family members with you, you must have approximately \$10,000 in additional support per dependent to cover the increased cost of room, board and insurance.

Residents of the Whitehorse, Yukon and Inuvik, Northwest Territory in Canada as well as residents of other countries which hold approved Sister City/Sister Province agreements, qualify for resident tuition. Undergraduate resident tuition and course fees is approximately \$7,652 and graduate tuition & course fees is approximately \$10,676 for the nine month academic year.
