Reporting directly to the Provost and Vice Chancellor for Academic Affairs, this position is responsible for the oversight of all operations, policies and procedures related to full- and part-time faculty. As such, I oversee faculty hiring, evaluation, personnel actions and appeals/grievances, professional development, workload monitoring, and implementation of the academic curriculum. Furthermore, I work in collaboration with all members of the Division of Academic Affairs to develop and maintain high-quality academic programs and ensure student success. I am responsible for budgets totaling more than \$1 million, and I supervise six direct reports.

This position focused on distance education, community outreach, regional partnerships, and military and veteran services. It had five direct reports, approximately 20 staff, and budgets totaling nearly \$6 million. These offices addressed the needs of UNCP's online and distance education learners through instructional design, technical support, proctoring services, and high-stakes testing services. This unit housed two federally funded grants that focused on job training for teenagers and young adults and provided perinatal services to women and their children in Robeson County, North Carolina. It also provided support services to military affiliated students, including active-duty service members and their dependents, veterans and their dependents, National Guardspeople, and reservists. The Office for Engaged Outreach was dissolved in 2018.
