Last Name, F. (Year, Month Date [use n.d. if not given]). *Title of Page*. Site Name. URL.

Book

Last Name, First Initial. (Year). *Title of book*. Publisher.

Online Journal Article

Last Name, First Initial. (Year). Title of article. *Title of Journal*, vol #(issue #), Page numbers. DOI
