Our consultant is a joint venture between Jensen Yorba Wall, a Juneau architectural firm and DLR Group. Krisan Osterby of DLR Group guided UAS through the 2012 master plan; some of you may remember her. The consultants plan to meet with UAS stakeholder groups, including Staff Council, the week of September 13, but no date has yet been set. I will keep you posted.
